**IFB ADDENDUM 2:  
REVISED TIMELINE  
UPDATE ON QUESTIONS/REQUESTS FOR CLARIFICATION  
REVISED CONTACT POLICY**

**May 22, 2019**

The purpose of this addendum is to provide a revised bid timeline, an update on questions/request for clarifications, and a revision to the Contact Policy outlined in Section 2.8 of the IFB. **Please Note:** It is the vendor's responsibility to ensure their receipt of all addenda and to clearly acknowledge all addenda within their bid response. Acknowledgement may be confirmed by inclusion of a signed copy of this addendum with bid response. Failure to acknowledge this addendum may prevent the bid from being considered for award.

**1) Revised Bid Submission Deadline**

The deadline for receipt of Bids has been extended. Bids must now be received and time-stamped at the Central Midlands Council of Government offices **no later than 3:00 p.m. on June 14, 2019**. Bids may be submitted in person, by messenger, or by regular mail. All bids will be logged in and date and time stamped. **Any bid package received after the date and time specified will be logged and date and time stamped as "late" and returned unopened to the BIDDER.**

**2) Update on Questions/Requests for Clarifications**

BCCEC has engaged a roofing consultant to conduct a moisture survey and provide technical assistance with answering questions received at the April 11, 2019 pre-bid conference/site visit. **We anticipate issuing a third addendum containing all the information needed to prepare a bid on or around June 5, 2019.** Per Section 2.6 of the IFB all addenda issued by CMCOG will become part of the official IFB and will be posted on the CMCOG website. The addenda will also be emailed to all vendors who attended the mandatory pre-bid conference/site visit.

**3) Revised Contact Policy**

Section 2.8 Contact Policy in the IFB has been revised and now reads as follows:

"No direct or indirect contact regarding this solicitation may be made with any representatives of BCCEC, Lexington County, CMCOG staff, **or consultants engaged by BCCEC**, other than the OFFICIAL CONTACT identified in this IFB. If such contact is made, BCCEC and CMCOG reserve

the right to reject a BID submitted by that BIDDER. This contact policy applies to separate site visits and requests for technical information. Any technical information needed to prepare a BID should be coordinated through the Questions/Requests for Clarification process outlined in Section 2.5.”
