Thank you for your interest in the Central Midlands Family Caregiver Support Program. This program is part of the National Family Caregiver Support Program and provides services for unpaid family caregivers who meet one of the following criteria. We CAN NOT pay the family caregiver to provide care to their loved one.

- Caregivers age 18 and older providing care to individuals 60 years of age and older
- Caregivers of individuals of any age with Alzheimer's disease, dementia, and related disorders
- Older relatives, including parents, age 55 and older providing care to adults ages 18-59 with disabilities

#### Available services include:

- Information to caregivers about available services
- Assistance to caregivers in gaining access to services
- Individual Counseling, organization of support groups, and caregiver training
- Respite Care A short-term break for caregivers
- Limited Supplemental Services Incontinence supplies, assistive devices, etc.
