1. WELCOME, INTRODUCTIONS AND CALL TO ORDER

Chairman Walton McLeod called the meeting to order at 12:10 p.m.

2. DETERMINATION OF A QUORUM

It was determined that a quorum was present.

3. <u>APPROVAL OF THE DECEMBER 5, 2023 MEETING MINUTES</u>

Larry Brigham made a motion to approve the minutes of the December 5, 2023 meeting. James Brown seconded the motion. All were in favor and the minutes were approved.

4. Project Updates

Darren Ledbetter of SCDOT provided an overview of the current active transportation projects within the Columbia Urbanized Area. The project categories included:

- COATS/CMCOG Widenings
- COATS/CMCOG Intersections
- COATS/CMCOG Interchange
- Bridge Replacement Projects
- Interstate Rehabilitation Projects
- Interstate Widening Projects

The status of preliminary engineering, right-of-way acquisition, and construction was presented for each project.

There was a brief discussion.

This item was accepted as information.

5. <u>FY 2024 – 2033 COATS MPO Transportation Improvement Program (TIP)</u>

Reginald Simmons requested a recommendation of approval to adopt the 2024 – 2033 Rural Transportation Improvement Program (TIP). Per federal guidance, every 4 years in coordination with SCDOT, CMRTA, and other agencies, the CMCOG reviews and updates its Transportation Improvement Program. This program serves as the short-range capital improvements program for funding and implementation of roadway, transit, and non-motorized transportation improvements projects. Included in the TIP are several major categories which include the guideshare projects, intersection improvements, project exempt from guideshare, transportation alternatives, and transit. Mr. Simmons referred to a handout which included the following:

Guideshare Program

- Approximately \$55 million is expected to be obligated through FY 2033 on road widenings, intersection improvements, planning feasibility studies, interchange improvements, and enhancement projects.
 - \$18.2 million investment in previous obligations to the US 1 Phases I Widening Project in Lexington County
 - \$6.8 million investment in the Macedonia Church Road Resurfacing Project in Newberry County
 - \$1.7 million investment in Exit 119 Interchange Improvement Project in Lexington County
 - \$13.8 million investment in US 1 Phases II & III Widening Project in Lexington County
 - \$8.3 million investment in the Longtown Road Resurfacing Project in Fairfield County
 - o \$1.2 million investment in Signal System Improvement Projects
 - o \$350,000 investment in Planning Corridor & Feasibility Studies
 - o \$150,000 investment in Intersection Improvement Projects

Exempt from Guideshare Federal Aid Bridge Projects

- Twenty (20) active projects have been identified.
- Over \$139 million in federal dollars have been obligated.
- New bridge projects will continue to be added on an annual basis.

Exempt from Guideshare Federal Aid Interstate & Corridor Improvement Projects

- \circ Ten (10) active projects have been identified.
- Over \$1.2 billion in federal dollars have been obligated.
- New interstate & corridor improvement projects will continue to be added on an annual basis.

Transit Program

- <u>Section 5310</u> Enhance Mobility for Seniors & Disabled Approximately \$801,000 investment in thirteen (13) projects.
- <u>Section 5311</u> Rural Transportation Formula Funds Approximately \$4.2 million investment in four (4) projects.
- <u>Section 5339</u> Bus and Bus Facilities Approximately \$341,000 investment in two (2) projects.

There was a brief discussion.

MOTION, approved

At this time a motion was made by John Thompson to adopt the 2024 – 2033 Rural Transportation Improvement Program. The motion was seconded by James Brown. All were in favor and the motion was approved.

6. 2024 & 2025 RPWP Amendment – Intersection Control Evaluation Process

Reginald Simmons requested a recommendation of approval to amend the 2024 & 2025 RPWP to add \$10,000 for the Intersection Control Evaluation Process. CMCOG in partnership with SCDOT, its member governments, and the COMET will implement an Intersection Control Evaluation Process. This will be a data-driven, performance-based framework and approach used to objectively screen alternatives and identify an optimal geometric and control solution for an intersection. The benefits to using this approach include:

- Implementation of safer, more balanced, and more cost-effective solutions.
- Consistent documentation that improves the transparency of transportation decisions.
- Increased awareness of innovative intersection solutions and emphasis on objective performance metrics for consistent comparisons.
- The opportunity to consolidate and streamline existing intersection-related policies and procedures, including access or encroachment approvals, new traffic signal requests, and impact studies for development.

The Intersection Control Evaluation Process will be a four-step process to assess each intersection. It will include the following:

- Scoping Analysis. The analysis will be sufficient to estimate a preliminary footprint of each intersection alternative to determine whether it is practical to pursue.
- Safety Analysis. The safety analysis will provide a basis to characterize safety performance of the possible alternatives.
- Operational Analysis. The primary goal of the operational analysis in the scoping phase is to determine if the intersection alternative will perform at an acceptable quality of service. Appropriate traffic control device warrant analyses may be conducted.
- Multimodal Considerations. The suitability of each alternative for pedestrians and bicyclists should be assessed with an emphasis on convenience and accessibility and consideration of pedestrian and bicyclist network information from local and community plans. Potential items to consider include the number of lanes to cross, protected versus permitted turning movements, and motorist approach speeds. Additionally, the multimodal assessment should consider the suitability of each alternative for transit, freight, and other large vehicle operations when applicable.

There was a brief discussion.

MOTION, approved

At this time a motion was made by John Thompson to amend the 2024 & 2025 RPWP to add \$10,000 for the Intersection Control Evaluation Process. The motion was seconded by Larry Brigham. All were in favor and the motion was approved.

7. UPDATE ON TRANSPORTATION PLANNING PROJECTS

Reginald Simmons and Guillermo Espinosa provided an overview of the Regional Bike and Pedestrian Master Plan.

- Stantec is the selected consultant for this project.
- SCDOT issued the NTP on December 5, 2023.
- Data collection has begun.
- Staff is working with SCDOT on developing a Project Stakeholder Committee

Mr. Simmons also shared a flowchart outlining the milestones for the project.

James Walden provided an overview of the US 76/176 Corridor Feasibility Study.

- WSP is the selected consultant for this project.
- SCDOT issued a NTP in October 2023.
- WSP is currently collecting existing conditions data.
- WSP is currently reviewing intersections along the corridor.
- WSP will provide an existing conditions presentation to the steering committee.

This item was received as information.

8. OLD/NEW BUSINESS

The committee discussed establishing a regular meeting schedule. The committee decided to meet once each quarter. They also included that if needed a meeting could be called at any time.

MOTION, <u>approved</u>

At this time a motion was made by Walton McLeod to establish a regular meeting schedule for the Rural Transportation Committee to meet once each quarter with the option to also meet on an as needed basis. The motion was seconded by Vina Abrams. All were in favor and the motion was approved.

SUBJECT: Allocation/Call for Projects: American Rescue Plan Act (ARP) of 2021

South Carolina Department of Transportation (SCDOT) is pleased to announce the *American Rescue Plan Act (ARP) of 2021* call for projects for rural and small-urbanized areas under the Section 5310-*Enhanced Mobility of Seniors and Individuals with Disabilities Program.* Signed into law on March 11, 2021, ARP provides \$30.5 billion in federal funding to support the nation's public transportation systems as they continue to respond to the COVID-19 pandemic. Funding is available for payroll and operations, unless the recipient certifies that it has not furloughed any employees. Although the Act states that funding is available for payroll and operations, funding will only support expenses eligible under the relevant program(s).

As published by FTA, the ARP Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities apportionment to South Carolina is:

South Carolina	Allocation
Small Urban	\$241,869
Rural	\$252,477

Expenses are eligible for activity retrospective to January 20, 2020. Funds must be directed to operations payroll and are eligible for reimbursement at 100% federal share. There is no match required. ARP funds available to South Carolina under this FTA allocation will be suballocated to existing subrecipients eligible under Section 5310 of title 49, United States Code who are currently or have previously been funded for award by SCDOT and remain eligible to receive federal funding assistance.

Examples of eligible operations payroll include:

- Administrative leave of operations personnel due to reductions in service or quarantine
- Operating & Wages
- Operations Overtime
- Operations Fringe Benefit



Requests under this call for projects must **not** have been awarded and/or reimbursed under previous suballocation from programs such as FY2021 Coronavirus Response and Relief Appropriations Act (CRRSAA).

Depending on the number of applications received by SCDOT for available small urban area funds, SCDOT reserves the right to limit the award amount to eligible small urban projects and/or transfer unutilized small urban area funds to support eligible rural area projects

The project application must be submitted via email to Diane Lackey, Transit Program Manager, (LackeyDM@scdot.org) no later than 5:00pm EST on March 8, 2024.

Applications <u>must</u> include the following in order to be considered responsive:

- 1. ARP application Letter of Intent on agency letterhead and signed by Executive Director identifying Small Urban or Rural area activities
- 2. Written scope of how requested funds will be utilized to include the activity dates for reimbursement of eligible payroll expenses
- 3. Budget summary for requested eligible expenses (100% federal funds) (attached)
- 4. Certification that the agency has not (attached):
 - a. Furloughed employees
 - b. Previously been reimbursed for the requested payroll expenses

If an applicant does not submit all of the above listed items within their request, their submittal may be considered non-responsive and returned without further review/evaluation. Late submissions will be rejected without opening. SCDOT accepts no responsibility for misdirected or lost proposals.

Applicants selected for award will be provided and must return to SCDOT the required signed certification and assurance documents package to be included in the executed agreement within 45 days of notification of ARP suballocation selection. <u>Failure to do so will result in forfeiture of the ARP funding suballocation.</u>

REQUESTED ACTION

The Central Midlands Council of Governments staff will request approval to update the FY 2024 & 2025 Rural Planning Work Program (RPWP).

PROGRAM DESCRIPTION

The 2024 & 2025 CMCOG Rural Planning Work Program (RPWP) is based on the CMCOG's 2045 Long-Range Transportation Plan, which was updated and approved by the CMCOG Board of Directors on December 9, 2021. Emphasis has been placed on developing a program which can be reasonably accomplished with available staff and consultant resources and which is consistent with the priorities of the CMCOG area. This 2024 & 2025 RPWP emphasizes activities that promote the implementation of the existing plan. The major projects to be completed in this two year timeframe include:

Congestion Management Plan Update

In partnership with the CMCOG & COATS MPO, the South Carolina Department of Transportation (SCDOT) intends to pilot an objective-focused and performance-based CMP that can serve as a model process for all MPOs in South Carolina. Through this pilot, a CMP will be developed for the Columbia Area Transportation Study (COATS) with components that will impact the CMCOG planning area.

Estimated Completion Date: December 2024

Regional Mobility Program

In partnership with the CMCOG & COATS MPO, the South Carolina Department of Transportation (SCDOT) intends to pilot a data driven and performance-based analysis of congested corridors in the CMCOG & COATS MPO Planning area to identify the transportation needs and mitigation strategies to address those needs. Through this pilot, the RMP will serve as a model process for all TMAs in South Carolina.

In December 2023, the CMCOG Board of Directors adopted the Regional Signal System Improvement Program. This program will retime and rebuild traffic signals from the approved prioritized list. Traffic signal retiming can create up to 85% percent operational efficiency. Staff have identified the ten projects from the approved 2045 LRTP Rural Prioritized List and will submit them for approval.
