

Open Enrollment Will Be Here Before You Know It!

Medicare Open Enrollment is right around the corner. Open enrollment runs **October 15 through December 7** and is the time of year when beneficiaries can make certain changes to their Medicare coverage. Take action during Open Enrollment to make sure your coverage will meet your needs in 2025.

Do you have questions about your coverage? Central Midlands Area Agency on Aging offers free, in-depth, and objective insurance counseling and assistance to Medicare-eligible individuals, their families, and caregivers. Our AAA's SHIP counselor, **JaJuana Davis**, can help with the following topics:

- How to enroll in Medicare
- Reviewing health or prescription drug plan options
- Assistance programs you or your loved one may be eligible for
- Medicare eligibility criteria
- Explaining how Medicare works with supplemental policies, such as retiree coverage, Medicaid, and other insurers
- Troubleshooting billing issues
- Submitting appeals
